Dorfner acquires ACS International

German company and ICPA supplier member Dorfner acquires ACS International, another long time ICPA supplier member.

As of August 8, 2017, Gebrüder Dorfner GmbH & Co. Kaolin- und KristallquarzsandWerke KG, a successful family-owned company headquartered in Hirschau, acquired ACS International, based in Tucson, Arizona, USA. For Dorfner, this represents another important step toward internationalization.
